Further it is to inform that, the Principal Chief Conservator of Forests (HoFF), AP, Guntur has also informed that the user agency has to submit the RoFR certificates to the Divisional Forest Officer, Proddatur (WL) Division at the time of processing of the Part-II. The same was also informed to the user agency through the portal (raising EDS in PARIVESH Portal) by the erstwhile Divisional Forest Officer, Proddatur (WL) Division through the reference 2<sup>nd</sup> cited. But the user agency has submitted an undertaking certificate stating that the Form-1 (for Linear projects) under RoFR Act 2006 from the District Collector will be submitted during stage-II approval.

Further it is informed that the **user agency is requested to show the exact locations of the proposed laying of underground optical fiber cable along the existing ROW of land in Compt. No. 322 of Gopavaram RF in Ramapuram Beat (Bit-1), Compt. No. 332 of Gopavaram Extn. RF, Valleruvaripalli Beat (Bit-2) and in Compt. No. 291 of C. Kothapalli RF in Valleruvaripalli Beat (Bit-3) in Badvel Range of Proddatur (WL) of YSR (T) Division Kadapa to forest range officer Badvel range So that the forest range officer Badvel can inspect the exact location and assess the actual extent of growth to be felled only, enumerate the quantity of its measurements to arrive the stock position. Hence after completion of above proces only, it is possible to process the diversion proposal**
