महोदय,

उपरोक्त विषय पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि राज्य सरकार निम्न बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें। ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:-

The proposals should be forwarded to Regional office after proper scrutiny and with clear recommendations of the State Government.

1. It is not clear from the proposal how the State Govt. had granted lease over the land covered under FCA.  
**Action Required:-** State Govt. may submit complete report in the matter.
2. It seems from the proposal that it is for renewal of lease. At para B.1 (i) mentioned 'Yes' but no details uploaded. State Govt. also forwarded the project simply without mentioning any background of the proposal.  
**Action Required:** State Govt. may review and clarify the same
3. Details of previous approval to be required at para B online Part I.  
**Action Required:** State Govt. may upload the details of previous approval at para B online Part I and submit with detailed note and in view of Hon'ble High Court of Nainital direction.
4. It is observed that last approval accorded by uttarakhand State Govt. by themselves for five years which expired in 2015. Now, the proposal submitted for 30 years lease.  
**Action Required:** State Govt. may clarify whether the activity still going on and what is the view of State Govt. for 30 years lease.
5. Alternative examine and uploaded online is not clear.  
**Action Required:** State Government may upload clear copy of alternatives examined in addl. document online Part I.
6. Forest land diverted is mentioned 0.02 in FRA but proposal submitted for 0.157 ha.  
**Action Required:** State Govt. may review and clarify the same.
7. No document found uploaded in additional document.  
**Action Required:-** State Govt. may upload the additional document with proper referencing.
8. Density mentioned 20 in Part II  
**Action Required:-** State Govt. may review and upload correct density in online Part II.

9. Slightly prone to erosion mentioned at para 6 of Part II.  
**Action required:** - State Govt. may submit the comment of DFO in this regard.
10. Authority letter is not uploaded at para A-2 (xvii) online.  
**Action Required:-** State Govt. may upload authority letter at para A-2 (xvii) online Part I.
11. Component wise breakup is not given at Para B 2.4 online Part I.  
**Action required:** State Government may upload component wise breakup at para B 2.4 online Part I.
12. The geo-referenced digital map and SoI toposheet of proposed road uploaded at para C (iii) (iv) is not C/S by DFO.  
**Action Required:-** The State Govt. may upload the geo-referenced digital map and SoI toposheet at para C (iii) (iv) duly C/S by the DFO.
13. KML file of proposed road is uploaded at para C in place of digital map.  
**Action Required:-** State Govt. may upload KML file of proposed road at para C online Part I .
14. Justification for locating the project in forest land is not C/S by DFO.  
**Action Required:-** State Govt. may upload the Justification for locating the project in forest area duly C/S by DFO at Para D (i).
15. In village wise breakup, the name of the village is mentioned as Mohan Chatti, while in documents, it is mentioned as village 'Vijni Chotti' and village 'Kumartha'.  
**Action Required:-** State Govt. may clarify the same.
16. From the KML file it appears that non-forest land is available, it is non-site specific activity.  
**Action Required:-** State Govt. may give the comments why it cannot be operated from non-forest land.
