CA scheme: The Wildlife Warden has proposed revised CA scheme for 3.04 ha of non-forest CA land contiguous to Sanamavu RF for diversion of 1.52 ha of forest land at an financial outlay of Rs. 72,18,500/- including engagement of protection mazdoor (Rs. 7.035 lakhs), erection of hanging solar fencing (Rs. 19.50 lakhs) and water harvesting structure (Rs. 12.00 lakhs)

a) Attention is invited to the guidelines issued by the Government of India in Lr No. 11-243/2011-FC dated 08.11.2017 and instructions issued in Principal Chief Conservator of Forests Ref. No. TS4/24632/2019, dated 07.06.2019 and 28.06.2022

on preparation of Compensatory afforestation scheme for the diversion of forest area proposal and these guidelines may be followed scrupulously.

- i) In planting estimate either semi circular bund or catch water pits may be provided.
- ii) Casualty replacement work for first year maintenance work alone @ 10% may be adopted,
- iii) Scrap weeding and soil working around the plants may be proposed from year maintenance onwards.
- iv) Further, for the installation of hanging solar fencing, strictly follow the guidelines and cost estimate approved by the Principal Chief conservator of Forests and Chief Wildlife Warden.
- vii) While preparing the CA scheme, instruction issued and Model cost estimate approved in Principal Chief Conservator of Forests Ref. No. TS4/24632/2022, dated 13.10.2022 should be strictly followed.
