Proposal for diversion of 5.117 ha of forest land for construction of Koraput-Singapur Road Doubling Railway Project from (Km.0.000 to Km74.800) by East Coast Railway.

On scrutiny of the above proposal submitted vide your memo under reference the following discrepancies have been noticed.

- 1. In site inspection report of DFO at Point No.8 i.e. "Item-wise breakup of the forest land proposed for diversion" has not been indicated item-wise.
- 2. In site inspection report of DFO at Point No.12 i.e. "Number of tree to be felled and its impact on the system" it has been mention the no. of tree enumeration instead of no. of tree to be felled.
- 3. The cost of ANR gap plantation @ 500 per/ha @ Rs.1,57,554/-ha for 11 ha. comes to Rs.1, 1,57,554x11=17,33,094, whereas it has been calculated as Rs.17,00,094/- which needs rectification.
- 4. The cost of watering with diesel pump set with bore well @ 5,53,688/- is for 5 ha. and it comes to Rs.1,10,737.6 per ha. for 11 ha. it will come 1,10,7370x11=12,18,113.6 or 12,18,114/-, whereas it is calculated as Rs.11,07,376/- which needs rectification.
- 5. Checklist has not been signed by DFO.

Hence, the diversion proposal in 4 sets is returned herewith for compliance and resubmission to this office for taking further action
