With reference to the subject and letter cited above, I am directed to inform that the additional information submitted by the State Govt vide letter dated 15.09.2021 has been examined in this office. It is observed that the proposal submitted initially is for the diversion of 54.933 Ha of Tamenglong-Phelong Section from Km 31.430 to Km 43.480 and till the date of REC it is the same.

Now, the Km mentioned in the forwarding letter dated 15.09.2021 is from 21.950 to Km 34.000 and also in the letter dated 19.08.2021 from PCCF & HoFF to Addl. Chief Secretary, Govt of Manipur.

In view of the above, the State Govt is requested to kindly clarify the exact KM for this particular proposal, so as to enable this office for taking further necessary action from this end.
