3. Part-I application has not been signed by the concerned authorized signatory.

Hard copy of Part-I proposal there is error in gross total of the project cost.

Check list No.07 has not been furnished in proper format.

Check list No.08 has not been furnished in proper format.

As per tree enumeration, there are 2855 trees furnished in the hard copy. But, in the online it has been mentioned as 2845, which needs to rectified.

8. The financial outlay of the CA scheme has been calculated for the year 2026-27 of the one-time cost norm, whereas in the write up, it has been indicated that commencement of Plantation from 2024-25.

9. All the maps should be signed by the authorized signatory.

Hence, the diversion proposal in 5 sets is returned herewith for compliance and resubmission to this office for taking further action.
