
Sir,

Please refer to the State Government's letter in the reference on the subject cited above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. State Govt is requested to kindly furnish the following information for further processing of this proposal:

- (i) The current status of mutation of the non forest land proposed for compensatory afforestation land.
- (ii) The analysis and reason for the selection of the proposed site from among the three alternatives.
- (iii) The compensatory afforestation scheme is to be authenticated and technically approved by the competent authority.
- (iv) The Under taking certificate for Addl.NPV by the user agency of the proposed area, if any.
- (v) The detail purposed wise break up of the land of the proposed sites.
- (vi) The corrected shape file of the proposed area is to be submitted as it is found incorrect.

State Govt is requested to kindly furnish the above information for further processing of this proposal.
