Attention of the Conservator of Forests is invited to the references cited.

The Conservator of Forests is informed that following shortcomings have been noticed in the report furnished on the additional details/clarification called for by the Government of India.

- i) In the Part-I of Form-A under component wise break up details of forest area required, details may be corrected as per the details furnished in area requirement statement.
- ii) Extract on IRC SP 20-2022 para 2.6.1 and 2.6.3 on clarification details furnished by the user agency has not been furnished.

iii) In the recommendation of the project proposal, the District Forest Officer has reported that, in the alignment of the proposed road of formation of road from Thimmalankadu to Kotturmalai village, no right of way was admitted.

However in the EDS reply the District Forest Officer has reported that, Right of way admitted in the Tamil Nadu Government Gazette notification of Kesarkuli RF and a copy of notification enclosed.

The District Forest Officer has not reported details the right of way No. allowed for Kotturmalai village and whether the proposed road alignment is lies fully in that Right of way.

iv) As observed by the Government of India, revised kml file of proposed road alignment lies in the forest area alone has not been uploaded in Part-I of Form-A.

Before forwarding the EDS reply through web portal, the Conservator of Forests should ensure that the details requested by the Government of India is furnished in complete shape and all the documents may be furnished in triplicate copy to this office.
