With reference to the subject and letter cited above, I am directed to inform that State Govt letter under reference (i) above has been examined in this office but found incomplete. State Govt is requested to furnish the following information for further processing of this proposal:-

- 1. The consent of NBWL clearance of the proposed area.
- 2. The copy of the PSC minutes as it is mandatory to submit as per Ministry's guideline dated 25.01.2024.
- 3. The justification for 3-alternate route examination along with detail ecological parameters viz., forest cover, tree canopy, habitation etc.
- 4. To clarify on the tree enumeration list as the uploaded enumeration list for 3370 Nos. is for 24.14 ha proposed road area whereas as the revised area breakup submitted for the proposed road is 24.00 ha. if required revised enumeration list is to be submitted.
- 5. The corrected kml/shape file of earlier submitted CA area i.e., 54.40 ha after reducing 13.926 ha (0.995 ha VDF & 12.931 ha moderately dense forest) area as the alternate site of 13.926 ha has now been identified and submitted.
