The user agency has applied diversion of forest land in Vaniyamallee RL 1200.00 m length and width of 7.00 metres formation of new approach road to an extent of 0.84 ha in Gummidipoondi taluk , Tiruvallur District . In this regard, it is to pointdout that the forest land on verification it is seen that in Vaniyamallee RL 1095.00 meters and width of 7.00 metres total to an extent of 0.7665 ha. Hence, revised proposal may be uploaded with Forest area wise length and width of forest area involved, road specification details such as carriage way portion, side berms, side drains on the lines stated above. The User Agency is informed that, only after receipt of requested details in full shape through on line for taking further action.



The user Agency is also requested to have a joint inspection of the area along with Forest Range Officer Gummidipoondi and furnish the details of actual area to be diverted so as to process the proposal.
