In continuation to this office letter Nos. cited above on the captioned subject, this is Sir, to inform you that, the site inspection to the Road Project from Siuli to Kadaligada under Bhanjanagar Rural Works Division vide proposal No.50071/2022 having State Sl No .OR-066/2022 dtd.02.12.2020 was conducted by the undersigned on dtd.20.09.2022 & 29.09.2022 in presence of the Executive Engineer, R.W. Division, Bhanjanagar and his staff and the ACF, Ghumsur North Division, Range Officer, Tarasing Range and his staff.

During the course of Site Inspection following shortcomings were noticed. The Executive Engineer, RW Division, Bhanjanagar is requested to comply the shortcomings and report compliance for further follow up action at this end.

- 1. The Serial Number of Pillar and GPS Co-ordinates mentioned on the pillars do not tally with that of the number and GPS Co-ordinates mentioned in the ORSAC approved DGPS Map of the proposed area.
- 2. The Revenue land required for the project have not been demarcated by posting of R.C.C. Pillars.
- 3. The status of revenue land as on 25.10.1980 has not be furnished by the User Agency.
- 4. The tree enumeration has not been properly done. Some trees standing outside the alignment area have been marked which are required to be excluded from the list.

However, the project proposal re-submitted by you in original of the aforesaid project is returned herewith in 6 (Six) sets of hard copies alongwith CDs for your kind reference and you are once again requested to re-submit the complete project proposal to this office after necessary due compliance at your level without any delay. Further, he is requested to depute his field staff who will contact with the Range Officer, Tarasing Range and co-operate him for early submission of revised enumerated tree list of the proposed area.
