Sub: - Diversion of Unbroken 59.606 ha. Forest Land (57.515 ha. for Mining & Ancillary activities including 1.417 ha. of Forest Land diverted earlier for Safety Zone along part surrender area + 2.091 ha for Safety Zone along M.L Boundary) in respect of Sanindpur Iron & Bauxite Mines of M/s Rungta Sons (P) Limited.

Sir,

On scrutiny of the above Diversion Proposal, the following deficiencies are noticed.

1. Part-I of Form-A prescribed under the Forest (Conservation) Rules'2003 should be filled in and enclosed to Diversion Proposal.
2. Typed copies of blanks form, i.e., Part-II, III, IV and Part-V of Form-A should be enclosed.
3. As per Letter No.R&DM-GE (GL)-S-63/13-4822/CS dt.12.02.2015 of the Chief Secretary of Odisha addressed to all Collectors, necessary Certificate should be furnished by the Tahasildar as regards status of total land involved in the project (both Forest & Non-forest) as per Govt. record as on 25.10.1980.
4. Check list duly filled in by the User Agency should be enclosed.
5. The Cost Benefit Analysis is to be prepared as per new guidelines issued vide Letter No.7-69/2011-FC (pt) dt.1.8.2017 of the MoEF & CC, Gol.
6. All papers / pages should be signed by the Authorised Signatory of the User Agency.
7. Certificate (NoC) from concerned District Magistrates under the Forest Rights Act'2006 is to be furnished.
8. The Land Schedule of total ML area authenticated by Range Officer, Koira and Tehsildar, Koira & DDM, Koira should be enclosed.
9. The applied area delineated in the **Topo Sheet** signed by the User Agency should be authenticated by the Range Officer, Koira and Tehsildar, Koira & DDM, Koira.
10. The DGPS Maps along with co-ordinates of the area applied for diversion should be authenticated by the Range Officer, Koira and Tehsildar, Koira & DDM, Koira.
11. Plan showing the Proposed Land Use (Plate No.V) should be authenticated by Range Officer, Koira and Tehsildar, Koira & DDM, Koira.

12. Lease Plan (Plate No.II) should be authenticated by Range Officer, Koira and Tehsildar, Koira & DDM, Koira.
13. Authenticated Plan showing the Existing Land Use should be submitted.
14. Safety Zone Map authenticated by Range Officer, Koira and Tehsildar, Koira & DDM, Koira should be submitted.
15. Authenticated Geological Plan of the ML area should be submitted.
16. Map showing Phased Reclamation duly authenticated by DDM, Koira should be submitted.
17. The Scheme for Phased Reclamation should be submitted.
18. The land schedule of non-forest land required for the instant proposal of each Revenue village with abstract and grand abstract signed by the concerned Range Officer, duly authenticated by the Tehsildar, Koira and DDM, Koira should be enclosed in the following proforma.

The Revenue Maps should be signed by concerned Range Officer and authenticated by the Tehsildar, Koira, and DDM, Koira.

24. The Lease Profile as prescribed in Para-2.1 (2) of the guidelines issued under the F.C. Act 1980 should be enclosed to the diversion proposal.
25. Undertaking to pay the differential NPV if any arises, all Compensatory levies demanded by the Forest Department should be enclosed to the diversion proposal.
26. In the on-line application, it has been mentioned that an area of 24.727 ha. identified in village Hamirpur and an area of 33.917 ha. identified in village Khampur for Compensatory Afforestation. The Scheme for Compensatory Afforestation should be enclosed to the Diversion proposal.
27. Plate Nos. should be assigned to all Maps.
28. The Proposal should be serially page numbered with Annexure numbering.

You are requested to comply with the deficiencies and re-submit the Diversion Proposal immediately for taking further action at this end.


