- II. Any permissions (proof of evidence) accorded for existing inspection path covered in the sanction orders of excavation of Branch Canal in Compt.no.71 of Dontali RF and Compt.no.73 of Kakturu RF, Nellore.
- III. It is also requested to clearly mention whether the proposal is for upgradation of existing inspection path or formation of BT road.

Hence the District Forest Officer, Nellore is requested to furnish the above information immediately for processing the proposal to this office for onward submission to the Prl. Chief Conservator of Forests, Andhra Pradesh, Guntur.
