corrected in the Part-I of Form 'A'.


- ii. The extract of IRC SP 20–2022 para 2.6.1 and 2.6.3 on clarification details furnished by the user agency should be enclosed.

The District Forest Officer is requested to report specifically the right of way number allowed for Kotturmalai village with reference to approved notification and whether the proposed alignment lies fully in that right of way.
- iv. Revised KML file of the proposed road alignment lies in the forest area alone be uploaded in Form I-A.
