Sub: Diversion of 4.97 Ha Protected Forest Land in favour of Shri. Jugai Minerals, Ghungur for Laterite Mining at Gut No. 223 at Village - Parli, Tal. Shahuwadi in District Kolhapur in the State of Maharashtra - Regarding.

Sir,

The undersigned is directed to refer to State Government, Maharashtra FLD-2317/C.R.234/F-10 dated 08.10.2018 and APCCF & Nodal Officer (FCA), Maharashtra letter No. Desk-17/NC/I/I.D- /683/17-18 dated 14.06.2017 on the above subject seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980 and to say that preliminary scrutiny of the proposal in the Regional Office (WCZ), MoEF&CC revealed following:

- i. Though it is certified that area is not within 10 Km of any Protected Area, Maps viz.. 10 Km radius map showing PA's and Protected area Distance Map is not submitted along with the proposal.
- ii. KML/ Shape file of Compensatory Afforestation land uploaded in the web-portal is not good, appropriate KML file has to be uploaded.
- iii. Part- II has been wrongly uploaded in the web-portal.
- iv. Details of facts as contained in the Part- II of the proposal viz. Topography of the area, Geology, Slope to erosion and Soil vulnerability to erosion are not mentioned.
- v. Differential GPS map along with co-ordinates for CA land is not submitted.
- vi. District Mining Officer, Kolhapur has mentioned in his letter dated 25.01.2016 that this area being narrow nature same is not suitable by geologically for working of mining.
- vii. Though it is mentioned that employment for 1000 people will be generated, information on employment potential likely to be generated in terms of Skilled, Semi-skilled and Unskilled persons/ mandays by implementation of the project is not mentioned properly.

viii. Details on progressive CA done till date in the Division is not mentioned by Deputy Conservator of Forests, Kolhapur in his Part- II. Revised Part- II may be submitted by the DCF concerned.

In view of the above, I am directed to request the State Government to submit information on the shortcomings, as indicated above, to this Ministry for further consideration of the proposal for approval under the Forest (Conservation) Act, 1980.
