I am directed to refer to your letter No.Van Bhumi-34/2016-1960/Va.Pa. dated 9.5.2017 and letter No.Van Bhumi-21/2016-3291/Va.Pa. dated 4.8.2017 on the above mentioned subject and to inform that the proposal has been scrutinized and it is observed that following documents/ information have not been furnished with the proposal:

- Details of the area calculation (length x width) of forest land proposed for diversion.
- A certificate of concerned DFO stating that survey numbers of the non-forest land involved in construction of proposed road does not fall under the category of deemed forests or otherwise where provisions of Forest (Conservation) Act, 1980 are applicable.
- Part-II & Part-III may be submitted in original.
- Action taken report on erring officials for the work in violation of F(C) Act 1980.
- Geo-referenced map of the proposed road in polygon shape with depicting the different forests in shape/ kml format.
- CA scheme over equivalent non-forest land along with 7-10 years maintenance, geo-referenced map & land suitability certificate of concerned DFO.
- Penal CA scheme over equivalent degraded forest land along with 7-10 years maintenance, geo-referenced map & land suitability certificate of concerned DFO.
- A proper justification along with the volume of the traffic survey for the requirement of 25 m ROW for the purpose of reconstruction of the proposed road.

Therefore, it is requested that the aforementioned documents/ clarifications may be submitted to this office for further processing of the proposal.

- Penal CA scheme over equivalent degraded forest land along with 7-10 years maintenance, geo-referenced map & land suitability certificate of concerned DFO.
- Since a large area of Reserved Forest is proposed for diversion, a proper justification along with the volume of the traffic survey for the requirement of 25 m ROW for the purpose of reconstruction of the proposed road.
