Sub: Proposal for Diversion of 31.489 Ha of Forest Land for widening improvement of Package-II of Akhegwo-Jessami Road Section of NH-202 into two laning of existing KM 326.018 (Akash Bridge) to KM 340.843 (Jessami) in the state of Manipur by NHIDCL-reg.

Sir,

Please refer to the Government of Manipur letter No. No.27/66/2022-(For & Envt) dated 24.08.2022 on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal forwarded by the State Govt has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The State Govt. is requested to provide following additional information for further processing of the case:

1) The KML / Shape file has been examined under DSS software and found that the computed shapefile is only 5.94 ha whereas the proposal for diversion is 31.489 ha. The State Govt is to resubmit the corrected KML / Shape file for diversion of 31.489 ha (showing separately the area for road construction & muck dumping).

2) The number of trees that area to be affected is 38304 trees which is approx. 1200 per ha. Whether all the trees enumerated are going to be felled or can be reduced.

3) Status of FRA certificate

4) Existing RoW and proposed RoW.

5) The widening improvement of Package-II of Akhegwo-Jessami Road Section of NH-202 into two laning is for existing KM 326.018 (Akash Bridge) to KM 340.843 (Jessami). What is the status of road prior to KM 326.018 and after KM 340.843.

The above additional information may be furnished at the earliest so as to enable this office taking further necessary action.
