It is informed that, the Chief Conservator of Forests, Ananthapuramu vide ref. 6th cited has submitted proposal diversion of 3.582 Ha of forest land for 4/6 laning of Karnataka / Andhra Pradesh Border to Gooty Section of NH-63 from design Ch 375+ 740 to Ch 433+030 in the state of Andhra Pradesh in favour of EE, National Highways, Anantapuram duly mentioning the length of the road. But, the details of width of the proposed road is not mentioned

In this regard, the EE, (R&B), NH Division, Ananthapuram is requested to furnish the total alignment of road from A to B on 1:50,000 Topo Sheet duly highlighting the forest land proposed for diversion in the above alignment and also the length and width of the road proposed for diversion, so as to confirm the area to be diverted and taking further action in the matter. If possible, the Executive Engineer may please personally brief the Nodal Officer, FCA on any working day with prior intimation.
