Sub:- proposal for diversion of 0.03 ha of forest land (Pvt.Rev.Forest) of village Madhapur for installation of High Transmission line connected to Arati Steel Ltd. At-Ghantikhali, Cuttack.

Ref:- Your Memo No.4506 dated 16.9.2022.

On scrutiny of the above proposal submitted vide your memo under reference the following deficiencies/descriptions have been noticed which may be complied immediately.

1. The check list pertaining to Transmission line has not been provided in the Diversion Proposal.
2. As per check list Sl.No.7 & 8 the required information has not been furnished in the prescribed proforma pertaining to forest land and non-forest land respectively
3. In the site inspection report, you have mentioned that 16.85 ha of non-forest land is involved in the project but in the online application, it has been mentioned as zero.
4. The GPS co-ordinates of the starting point and end point of the Transmission line need to be mentioned.
5. In the Part-II, Col.No.ix, the distance of the Reserved Forest from the proposed site has not been mentioned.
6. In the site inspection report, Col.No. 16, the non-forest land used in the project is included in the DLC report or not, need to be mentioned.
7. During site inspection you have reported that the UA has already completed the construction of towers of transmission line on the said plot and transmission line is already functional illegally without obtaining forest clearance from GoI, MoEF & CC violating para-4.4 of the guideline of FC Act. The action taken report need to be mentioned.

In view of the above, the proposal received in your memo under reference is returned herewith for necessary compliance and resubmission of the same to this office at the earliest.
