P.ride With reference to your letter No. 20124 dt. 29.9.2018 on the subject mentioned above, I am directed to say that upon perusal of the above mentioned forest diversion proposal, the following shortcomings are noticed.

- (i) Justification for locating the project on forest land with details of alternative sites examined for the project as per provision of para 2.1(vii)(3) of FC Act guidelines for avoiding/minimising use of forest land has not been provided.
- (ii) Basic information of Bolangir District/Forest Division have been furnished in the FDP at page 52-53. Since the project is to be established in Subarnapur district, basic information of Subarnapur District and Subarnapur Forest Division duly signed by APCCF(Nodal) shall be furnished.
- (iii) Soft copy of DGPS map of forest land proposed for diversion in CD form shall be furnished.
- (iv) Employment(Regular/temporary) likely to be generated owing to this project shall be indicated.
- (v) C:B Analysis pertaining to this project, if required as per guidelines of MoEF&CC dt. 1.8.2017 shall be furnished.

In view of importance of this infrastructure project in LWE affected district of Subarnapur, it is requested to furnish the required compliance in three sets to this department **urgently** for processing the proposal at this end.
