Sub: Diversion of 13.233 ha of forest land for construction of Air Strip at Malkangiri in
Malkangiri District (**Proposal No. FP/OR/ OTHERS / 30494 / 2017**)

Ref: Your Memo No.3900 / 4F (Misc) dated 19.10.2020.

On scrutiny of the above diversion proposal submitted vide your memo under reference,
the following discrepancies are noticed.

1. In the Application Form-A, at part-II, legal status of the forest land proposed for diversion for construction of Air Strip has been reported as "Revenue Forest" In this regard-
 - a) The DGPS map of the revenue forest land proposed for diversion has not been authenticated by the concerned Tahasildar.
 - b) The land schedule as well as the village maps relating to said revenue forest land have not been authenticated by the concerned Tahsildar.
2. In the Site Inspection Report at point No.6, the legal status of the forest land has not been reported by the DFO.
3. In the Site Inspection Report at point No.8, item-wise break up of forest land proposed for diversion has not been furnished. But village-wise break up of forest land has been furnished.
4. A DGPS map of land identified for Compensatory Afforestation has not been authenticated by the DFO.
5. The DGPS map of the C.A. land has not been authenticated / certified by ORSAC whose Geo reference survey has been carried out through ORSAC empaneled agency Map Tech Solutions, Private Limited, Bhubaneswar.
6. The wage rate has been enhanced from Rs 303.40 P to Rs 308/- per Manday with effect from 01.10.2020 vide letter No.6100 / LC, Bhubaneswar dated 21.10.2020 by the Labour Commissioner, Odisha which has been communicated by the Deputy Conservator of Forests (Admn), office of the PCCF (Wildlife) & Chief Wildlife Warden, Odisha vide his Memo No.8603 dated 22.10.2020. So, the cost of the scheme for compensatory afforestation is to be revised accordingly at present wage rate of Rs 308/- per Manday.

The Diversion proposal in four sets are returned herewith for proper compliance and resubmission.
