In Part-III, the Chief Conservator of Forests, Trichy has uploaded Part-III format only. He has not uploaded his Field Inspection Report and recommendation letter. The Chief Conservator of Forests is requested to upload the Inspection report and recommendation letter.

The Chief Conservator of Forests and the District Forest Officer area requested to rectify the above shortcomings and upload the same. The timeline for submission of proposal prescribed in the Forest (Conservation) Act, 1980 guidelines should strictly be followed.
