Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of 1.785 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the Govt of J&K, the following information/clarification is still required to be submitted:

- i. FRA/ Undertaking to provide FRA is not submitted.
  - ii. Village wise breakup of forest land is not uploaded for all villages, which are falling under proposed road alignment i.e. Choura gali, Namplan, Moku, Brade, Talipera etc.
  - iii. SOI Toposheet number is missing from CA & Project site Toposheet.
  - iv. DFO is required to recommend the biological measures for stabilization of dump sites in the forest area as the information submitted by the UA describes only mechanical measures to stabilise the dump sites.
3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
