Sub: Forests - Diversion of 0.84 ha of forest land in Nallur RF for laying access road to reach Engineering College run by M/s Sapthagiri Educational Trust in Kancheepuram District – Orders issued - Factual report sought by the Government of India – Discussion with the District Forest Officer, Chengalpattu Division held on 31.08.2023 at Secretariat-Regarding.

Attention of the District Forest Officer is invited to the reference cited, wherein the Government has informed that the factual report furnished in Principal Chief Conservator of Forests letter No. TS3/28217/2000, dated 14.02.2023 in respect of the forest area used for approach road to reach the Engineering College by the Sapthagiri Educational Trust is completely in contradictory to earlier reports furnished by the Principal Chief Conservator of Forests in letter No. TS3/28217/2000, dated 11.05.2018. Hence, a meeting has been conducted with the District Forest Officer, Chengalpattu Division on 31.08.2023, during which the District Forest Officer has reported that the present road is not in right of way No. 6 Government had issued orders allowing road in cart-track No. 6 as proposed in Principal Chief Conservator of Forests reference No. TS3/28217/2000, dated 10.07.2001. It is clear that the road formed by Sapthagiri Educational Trust is not the right of way No. 6 for which permission was accorded by Government. Hence it is considered that there is a violation of Forest (Conservation) Act 1980 in this matter.


Subsequently, the user agency has sent a proposal (No. FP/TN/Road/17771/2016) for widening of approach road for which no permission has been obtained for the existing road and hence the present proposal for diversion of 0.64 ha of forest land furnished by the Sapthagiri Educational Trust for widening of the existing road cannot be considered, since the existing road is not a legal one as per the Forest (Conservation) Act, 1980.


Therefore, the Government has requested the Principal Chief conservator of Forests to enquire into this in detail and send factual report on the above violation to Government immediately so as to forward the same to the Government of India.

The District Forest Officer is requested to furnish the report furnished to the Government during the meeting held on 31.08.2023 at Secretariat, Chennai and furnish detailed factual report on the above issue immediately through the Chief Conservator of Forests, Chennai Circle.

I am directed to invite attention to your letter first cited, wherein you have requested orders for diversion of 0.84 ha of forest land in Nallur Reserved Forests (Cart-track No.6 Right of way 12 feet width) for laying approach road to reach Engineering College to M/s. Sapthagiri Educational Trust. Accordingly, the Government have issued orders in the reference second cited, for diversion of 0.84 ha of forest land in Nallur Reserved Forests for laying approach road to reach Engineering College to M/s. Sapthagiri Educational Trust.

2. In this regard, I am to state that the factual report sent in your letter 12th cited in respect of the forest area used for approach road to reach the Engineering College by the Trust is completely in contradictory to your earlier report in the reference 4th cited. Hence a meeting has been conducted with the District Forest Officer, Chengalpattu Division on 31.08.2023, during which the District Forest Officer has reported that the present road is not in right of way No.6. Government had issued orders allowing road in cart-track No.6 as proposed in your letter first cited. It is clear that the road formed by Sapthagiri Educational Trust is not the right of way No.6 for which permission was accorded by Government. Hence, it is considered that there is a violation of Forest (Conservation) Act, 1980 in this matter.


3. Subsequently, the User Agency has sent a proposal (No.FP/TN/Road/17771/2016) for widening of approach road for which no permission has been obtained for the existing road and hence the present proposal for diversion of 0.64 ha of forest land furnished by the Sapthagiri Educational Trust for widening of the existing road cannot be considered, since the existing road is not a legal one as per the Forest (Conservation) Act, 1980.

4. I am, therefore to request you to enquire into this in detail and send factual report on the above said violation to Government immediately, so as to forward the same to Government of India.
