महोदय,

उपरोक्त विषय पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि राज्य सरकार निम्न बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें। ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:-

1. Some other document uploaded in place of justification at para D(i) online Part I.  
**Action Required:-** State Govt. may review and upload the correct documents and submit in original hard copy also which is duly c/s by DFO.
2. C/B analysis is uploaded in old format.  
**Action Required:-** State Govt. may upload the C/B analysis as per Ministry guidelines dated 01.08.2017 and submit the same in hard copy.
3. VLC proceedings of village Naugaon and Purola are not found uploaded.  
**Action Required:-** State Govt. may upload the VLC proceedings of village Naugaon and Purola.
4. In geologist report mentioned at para 7 that 'construction of bridge is right'. However the proposed is for road.  
**Action Required:-** State govt. may review and clarify the same.
5. Total quantity of muck to be disposed is 1, 13, 388/- cum but muck disposal plan is not appropriate.  
**Action required: -** The State Govt. may submit detailed muck disposal plan with complete details of measures, plan and photograph of site which is duly c/s by DFO.
6. Density mentioned in Part II is 0.7 and 0.2 but calculation sheet uploaded for 0.5 density.  
**Action required: -** State Govt. may review and submit revise NPV calculation sheet.
7. Two CA scheme of different ha. is found uploaded for same area. As per DSS, only one patch found upoaded for total area.  
**Action Required:-** State Govt. may clarify for submitting two CA scheme.
8. Working plan detail is not filled correctly. It is mentioned that working plan expired in 2015.  
**Action Required:-** State govt. may filled correct working plan details at para 5 online Part II .

9. Following documents have not been found uploaded in web portal.

- a. Financial outlay.
- b. CA scheme.
- c. CA site suitability certificate.

**Action Required:-** The State Govt. may upload the above mentioned documents at designated place online.

10. At para 15 & 16 in Part II, no comment & recommendation are made by DFO.

**Action Required:-** DFO may mention comments against each column at para 15 & 16 online Part II.

11. The following documents are required to be submitted in original:-

- a. Ownership proof details.
- b. Digital map of proposed road.
- c. Digital map of CA area.
- d. Undertaking to bear CA cost

**Action required:** - The State Govt. may submit the above mentioned documents, in original.

12. Out of total proposed area for diversion, 6.1650 ha falls in RF out of which 4.226 ha is for muck disposal.

**Action required:** - State Govt. may review the same and shift the muck dumping sites to other area.

13. Geo-referenced points of muck dumping sites are required.

**Action required:** - State Govt. may submit muck dumping sites.

14. Site inspection report of forest division is not correctly filled/incomplete and lacks any recommendation also.

**Action required:** - State Govt. may submit correct site inspection report and upload the same.

15. Original hard copy of FRA certificate is not submitted.

**Action Required:-** State govt. may submit the original hard copy of FRA certificate.

16. Justification for locating the project in forest land is not C/S by DFO.

**Action Required:-** State Govt. may submit original hard copy of Justification for locating the project in forest area duly C/S by DFO and upload the same at Para D (i) online Part I.


17. Aerial distance from nearest PA is shown as 40 km. Since ESZ of Bhagirathi NP is 100 km.

**Action Required:-** State Govt. may submit the clarification in this regard. If the proposed road falls in ESZ then comments of CWLW are required.

18. Reclamation plan of muck dumping is not submitted.

**Action Required:** State Govt. may submit original hard copy of reclamation plan and also upload the same at designated place.
