3. As per DSS analysis previous plantation impressions are observed on CA area and KML file of CA area is only 17.20 ha instead of 28.00 ha. Correct KML file of CA land shall be uploaded on web portal.
4. Detailed & complete CA scheme along with year wise progress details shall be submitted & uploaded.
5. FRA certificate in proper format shall be submitted and uploaded.
