In inviting a reference to the subject cited above, it is to inform you that, the required compliance of short coming for diversion proposal of 4.16 Ha. of revenue forest land in Phathamunda village of Rampur Tahasil for construction of Adarsha Vidyalaya (Model School) Dunguripali in Subarnapur District raised by Special Secretary to Govt., F&E Department, Odisha communicated to your office vide his memo No. 21526 Dt. 05.10.2018 which has been complied and re-submitted to the undersigned vide your office letter No. 5265 Ft. 25.10.2018 found incomplete after scrutiny.

4. Employment (Regular/temporary) likely to be generated owing to this project shall be furnished in detail. **(Partly furnished)**
5. C:B Analysis pertaining to this project, if required as per guidelines of MoEF&CC Dt. 01.08.2017 shall be furnished. **(Not required)**
