महोदय,

उपरोक्त सन्दर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरांत निम्निलिखित कमियां पाई गयी हैः

- 1- Implementation Agreement is not provided by the State Govt. Hence, the State Govt. may submit the Implementation Agreement to this office.
- 2- In the project allotment letter from the State the capacity of the project is mentioned as 15 MW but in Techno-Economic Clearance & other documents it is mentioned as 16.5 MW. The clarification in this enhanced capacity may submit by the state govt. and revised the allotment letter for enhanced capacity.
- 3- The area selected for muck dumping is 2.6159 ha in the forest. The State Govt. may explore some non-forest area for muck dumping and submit the separate enumeration for this area proposed for muck dumping.
- 4- The State Govt. may provide enumeration as per the format prescribed to Nodal office by this office.
- 5- In view of species the eco-class state govt. may re-asses and revised the NPV calculation accordingly.
- 6- The State Govt. not submitted the detailed evacuation plan to this office and nor the detail over CAT plan the document submitted in this regard does not solve the purpose. Therefore, the state govt. may submit the CAT Plan and all documents in this regard duly authenticated by DFO to this office.
- 7- The State Govt. may submit the details of width & length of T/L including other linear components of the project to this office separately.
- 8- The State Govt. may mark the name of the components in the KML file which is uploaded in Part-I online.
- 9- The State Govt. may ensure that all the project components are shown clearly in the SoI Toposheet, Geo-referenced map and the general layout plan.
- 10- It is seen from the detail note about the project that the intake structure of Sai Kothi-II HEP is on the Tail Race Outlet of Sai Kothi-I HEP. As a result of this arrangement, a long stretch of Baira Nallah is likely to remain dry for most part of the year specially during lean season which is harmful for the aquatic flora & funna. Therefore, the State Govt. may intimate the details of the hydro electic projects proposed to be developed on Baira Nallah in cascade manner including the stretches of Nallahs between the diversion structures and Tail Race along with maps. State Govt. may also intimate the safeguards taken to maintain ecological flow in the Nallahs.

- 11- The intake structure of Sai Kothi-II HEP (16.5 MW) is on the Tail Race Outelt of Sai Kothi-I HEP. Hence, the State Govt. may intimate the status of construction of Sai Kothi-I HEP.
- 12-Online application has been uploaded by Shri Rajeshwar Singh but the authority letter has been issued in the name of Shri Surinder Kumar Para-A-3 (i,ii&iii) and A-3 (x) of online Part-I. Hence, the State Govt. may clarify the discrepancy in this regard.
