Sir,

Please refer to the subject and reference cited above. I am directed to request to
kindly furnish the following information / clarification at the earliest for further
processing of the subject proposal;

- The User Agency in online application, has been reported that the shape of
the forest area proposed for diversion as "linear", however, as per the kml
file and the component wise breakup, the proposal is appears to be "non-
linear" in nature. Hence, same shall be rectified;
- As per the DSS analysis done in this office, the proposed forest area for
diversion falls within the Protected Area i.e. Kaundinya Wildlife Sanctuary,
but, as reported by the State Government, the proposed forest area is 1.5 kms
away from the boundary of the Kaundinya Wildlife Sanctuary and falls in
notified Royala Elephant Reserve. Hence, it is to request to clarify whether
the area proposed for diversion falls within the protected area or its Eco
Sensitive Zone (ESZ). In addition, comments of the Chief Wildlife Warden
may also be furnished on the above matter especially on impact of the project
on fauna of the Royala Elephant Reserve along with mitigative measures, if
any required, as the case may be.
