Subject: Uploading of remaining road proposals on PARIVESH Portal for obtaining ex-post facto approval under the Van (Sanrakshan Evam Samvardhan) Adhiniyam.

Sir,

It is to bring to your notice that the Government of India has raised observations in respect of certain road projects which are under process for obtaining approval, as these have been constructed in violation of the provisions of the *Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980*, and have been reported to the Hon'ble High Court of Himachal Pradesh due to non-uploading of the remaining road proposals on PARIVEHS Portal for obtaining ex-post facto approval under the said Adhiniyam.

The Government of India has pointed out that although a period of six months has already elapsed, all the proposals have not yet been uploaded or processed for approval on the PARIVESH Portal. As per the information available, the user agencies have so far submitted only the abstract of **815 proposals**. However, the remaining proposals for regularization of encroachments under the provisions of the *Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980* have not yet been uploaded on the PARIVESH Portal.

In view of the above, it is requested to upload the remaining proposals on the PARIVESH Portal at the earliest, so that the approval may be obtained from the Government of India in all remaining cases.

महोदय,

मुझे आपका ध्यान उपर्युक्त विषय से संदर्भाक्ति पत्र की ओर दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 की धारा- 2 के अनुसार गैर वानिकी उद्देश्य के लिए 3.2193 हेक्टेयर वन भूमि की मांग की गई है।

2. वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 के उल्लंघन के 2183 मामलों से सम्बंधित प्रस्तावों पर 23.09.2024 को आयोजित सलाहकार समिति की बैठक में चर्चा की गई और निम्नलिखित निर्णय लिए गए। अतः सम्बंधित जानकारी भेजने का कष्ट करे।

1. State Government has only submitted the abstract of the 2183 proposals. State Government has not yet uploaded the remaining proposals on the PARIVESH portal for regularization of encroachments under the V(SS)A,1980, as required within six months of the issuance of the Minutes of the AC Meeting.
2. Therefore, the State Govt. shall upload the remaining proposals on the PARIVESH portal at the earliest, since the six months' time period has elapsed from the issuance of the Minutes of the FAC Meeting dated 23.09.24
