Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the abovementioned subject seeking prior approval of the Central Government for diversion of 2.982 ha. of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

- 2. After careful examination of the information submitted by the Government of J&K, the following information/clarification is still required to be submitted:
- i) As per FSI-DSS analysis, one ha area out of proposed 6 ha for undertaking CA, is moderately dense forest (canopy density of 40%-70%) and approx. 2.90 ha is under mature/middle height trees/vegetation as per Google earth image. Hence, revised CA site of only 10-40% vegetation needs to be submitted with sufficient vacant space to accommodate the target plantation.
- ii) The DGPS map, SOI toposheet and Site suitability certificate of revised CA site, accordingly may be modified.
- 3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
