On scrutiny of the compliance report furnished by the FD, STR-cum-RCCF, Baripada Circle, the following observations are noticed:-

- 1) In compliance to observation No. 2 of GoI letter dated 18.04.2023, it is observed that you have forwarded the copy of the action taken report furnished by the project proponent. Nature of activities undertaken and extent of forest area used therein for non-forestry purpose has not been furnished.
- 2) KML File of the new CA land has not been furnished. As a result, DSS analysis and approval of the CA scheme/CB analysis could not be done.

In view of the above, I am directed to request you to furnish the above documents/information for further course of action.
