Madam/Sir,

Please refer to Government of Rajasthan's letter No.P.1(37)VAN/2022 dated 09.07.2025 on the above mentioned subject. In this context, the observations of the Ministry are as follows:-

- (i) The State Government instead of submitting the condition-wise compliance on the conditions stipulated in FC approval for diversion of 398.0085 ha of forest land under the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 vide Ministry's letter No. 8-14/2021-FC dated 11.03.2022, the State Govt. has submitted the cluster Mining plan of Paharpur Sandstone Mine (Block A & B). The State Govt. shall submit condition-wise compliance of earlier approval.
- (ii) Further, As per para 7.8 (i) (e) given in Chapter-7 of the Consolidated Handbook of Guidelines and clarification issued under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 issued by the Ministry on dated 29.12.2023 states that "Any proposal for diversion of forest for mining involving any forest land in respect of which diversion has been approved earlier will invariably be submitted along with the present status of compliance of the conditions of all previous FCs duly certified by the concerned Regional Officer of the MoEF&CC". Therefore, the State Government shall submit the compliance report on the conditions stipulated in the approval accorded by the Ministry's letter No. 8-14/2021-FC dated in the approval accorded by RO, Gandhinagar.
