विषय : Diversion of 9.739 ha of forest land in favour of HPSEB Ltd. for the construction of Devi Kothi Hydel Electric Project (16.00 MW), within the jurisdiction of Churah Forest Division, Distt. Chamba , Himachal Pradesh. (online no. FP/HP/HYD/32280/2018)

महोदय,

उपरोक्त सन्दर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त निम्नलिखित कमियां पाई गयी हैं:

- 1- Non-linear components of the proposed projects are not shown properly in the KML file uploaded in online portal neither captioned by colour or name of the component in order to differentiate properly. The same may be carried out by the State Govt.
- 2- In the geo-referenced map 8 component are shown same as in the land schedule in the hard copy of the proposal but in online para B 2.4 (component wise breakup) details of all components are given.
- 3- The State Govt. provided CA over degraded forest land while as per the guideline of CA over degraded forest land is permissible only in the cases of small HEP upto 25 MW having area not exceeding 5.0 ha. Therefore the State Govt. may submit the CA over equivalent non-forest land. & do necessary correction accordingly.
- 4- Implementation Agreement is not provided by the State Govt. Hence, the State Govt. may submit the Implementation Agreement to this office.
- 5- The State Govt. may submit an undertaking that the CAT plan for the treatment of micro watershed of this project in consonance with the comprehensive CAT Plan of Ravi Basin shall be prepared and implemented in consultation with state forest department at the project cost duly authenticated by the DFO.
- 6- Power evacuation plan may be submitted by the state govt. in detail because the state govt. has mentioned that T/L will be dealt by Electrical system of HPSEBL which is not satisfactory.
- 7- One more power house has been shown in the upstream side of diversion weir which is required to be clarified by the State Govt.
- 8- It is mentioned in the justification that the HRT will be underground but in the forest land proposed for diversion by the user agency HRT has not been incorporated in the component wise break up which is submitted by the state govt. to this office.
- 9- Enumeration list of trees at FRL-2 m & FRL-4 m has not been provided.
- 10- Online application has been uploaded by Shri Rajeshwar Singh Marh (A-3 (i) to iii) but authority letter has been issued in favour of Er. Rajeev Sharma (A-3 xvii).

- 11- It is seen from Para B 2.3 (village wise breakup) that the forest land proposed for diversion falls within jurisdiction of Majohga, Galua, Lower Tein, Sanol villages but the VLC proceedings under FRA has not been provided for Sanol village.
- 12- The information pertaining to CAT plan filled up at Para 14 (ii) (a) & (3) is not appropriate. Hence, the State Govt. may review the same.
- 13- It is seen from KML file of the proposed CA area for Patch-1 i.e. Galus (4.90 ha) that some agriculture land is included in the polygon.
- 14- Name of the project not mentioned in the recommendation of CF, Nodal Officer and state Government.
