उपरोक्त विषय के सम्बन्ध में आप द्वारा भेजे गए प्रस्ताव का अवलोकन करने
उपरांत उसमें निम्नलिखित कमियां पाई गई हैं:-

1. FRA/Undertaking for FRA needs to be submitted.
2. In part-II (Additional Detail) All undertaking/Documents submit by UA is required to uploaded with name of document and counter sign by DFO.
3. Clear copy of Administrative approval needs to be uploaded.
4. Irrigation department NOC needs to be uploaded.
5. Separate NPV calculation sheet has to be submitted and it has to be removed from the CA scheme.
6. B-2.3 wise break up needs to be uploaded.
7. 646 trees of various species are proposed to be felled, but details of maximum species are uploaded under miscellaneous species in Part-II under column 4 (ii). This needs to be uploaded for all species along with their scientific and local names.
8. Revised CA plan for undertaking plantation for 646 (No of tree to be felled)x10 times 6460. The revised CA scheme has to be prepared and submitted.
9. SOI toposheet should none a toposheet number and a clear print of the toposheet.
10. KML files does not indicate exact location for plantation of 4921 number of plants as indicated in the CA scheme.
11. DGPS maps needs to be modified as per the rectified KML file.
12. It is not clear from the CA scheme, if NFL is proposed for undertaking CA. Hence, it has to be clearly indicated in CA scheme, the details of NFL and DFL as per following format :
