2. From the perusal of the reply as submitted vide above referred EDS it reveals that the reply of the shortcomings are not being scrutinized properly. The following shortcomings have been noticed which may be attended in all respect: -

1. In response to point No. 1, no encloser has been found attached with the Memo, these are required to be uploaded giving the detail of Sr. No. column No etc.
2. The GoI has asked for giving the alternatives in more details and must give complete justification establishing its inescapability for locating the project in forest area. Further, explored alternatives showing details of tree enumeration, area etc. The justification for locating the project duly countersigned by DFO should be revised and uploaded against the appropriate column of Part-I by including the facts as asked for.
3. The layout plan as uploaded online is not authenticated by DFO concerned.
4. In response to point No. 4, the open area of 1.4 has still proposed which need to be justified.
5. In response to point No. 6, the Soil Moisture Conservation Plan is required to be prepared and uploaded accordingly. Moreover, in case it is not ready yet, an undertaking for providing the same may be provided/ uploaded.
6. In response to point No. 7 & 8, the NoC of HPPWD and NoC of HPSPCB stated to have been uploaded but no such document have been found on portal.
7. In response to point No. 11, no encloser has been found attached with the Memo, these are required to be uploaded giving the detail of Sr. No. column No etc.

You are, therefore, once again requested to ensure the proper scrutiny of each observation as raised by GoI and upload the requisite document online by mentioning the reference of uploaded document (i.e. Sr. No., column No. & Part) in forwarding memorandum.
