**Diversion of 3.677 ha of forest land in favour of HPPWD for the
Construction of link road from Nadal to Village Jatrahan Kms
0/0 to 7/0, within the jurisdiction of Churah Forest Division Distt
Chamba, HP.**

Kindly refer to your office letter No.D-V/582/G/3496 dated 6.9.2021 on the subject cited above.

2. The proposal received has been found incomplete. The following shortcoming has been noticed in the proposal which is to be completed. Proposal folders received are returned herewith. All the requisite documents may please be placed in the proposal folder with proper numbering and index.

1. The legal status of the forest land proposed for diversion has been mentioned DPF in hard copy of part-II whereas in online part-II, only protected forests has been mentioned. Necessary correction is required to be made in online part-II.
2. In one of the proposal folder, the check list Sr. No.7, the detail of Forest land has not been signed by the DFO concerned.
3. Large number of trees is involved in the proposed proposal. Over 3.677 ha of forest land 932 trees are standing. Necessary efforts should be made to reduce the number of trees. GoI does not consider the proposals having huge number of trees.
4. CA has been proposed over 7.354 ha of forest land whereas in the detail of CA patch, the forest area 3.677 ha has been mentioned instead of 7.354 ha. Further, while viewing the KML file of CA site, it is not downloaded. The revised KML file of CA site is required to be uploaded against column No.13(i).
5. Further, CA has been proposed in lieu of 3.677 ha whereas in the hard copy, CA scheme placed at P.Nos.74-78, Detail scheme for Compensatory Afforestation to be carried out in lieu of 0.86 ha has been mentioned.
6. In the bill of NPV, Group 8 Sub tropical broad leaved Forests has been mentioned but the eco class-VI has been mentioned and bill of NPV has also been calculated for Eco Class VI. It is clarified that Sub tropical broad leaved Forests, comes under Eco class-V and not eco class-VI. The bill of NPV is required to be calculated for eco class-V and necessary corrections is also required to be made against column No.4(i).
7. Dumping has been proposed over 0.627 ha of forest land but the cost estimate of plantation part has not been found placed in the proposal folder.

8. P.Nos. 91-98 have not been signed by the user agency.
9. Although distance certificate from the protected area has been uploaded online and placed in the proposal folder at P.No.100. But from the perusal of requisite distance certificate, it has not been made clear whether the distance mentioned is aerial or otherwise.
10. The photocopies of all the documents duly attested are required to be placed in the proposal folder.
