विषय: Diversion of 0.6806 hectare in favour of Sanjeev Hydro Projects Private Limited VPO Sauhora Tehsil & District Kangra for construction of Lower Iku Small Hydro Electric Project (1MW), within the jurisdiction of Dharamshala Forest Division, Distt. Kangra, H.P. (Online Proposal No. FP/HP/HYD/41472/2019).

महोदय,

उपरोक्त विषय पर संदर्भित पत्र का आशय ग्रहण करते हुए सूचित करना है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी है। अतः राज्य सरकार निम्न बिन्दुओं पर आवश्यक सूचनाएं प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:-

1. The tree enumeration, in separate, may be provided for the area proposed for muck dumping in the proposal.
2. The State Government may provide plantation scheme of 1360 plants.
3. The muck dumping plan should be authenticated by the concerned DFO.
4. In the Feasibility Report (FR), the tentative area for the project is estimated as 0.3925 ha. The State Government may clarify that why the area proposed for diversion be increased from 0.3925 ha to 0.6806 ha.
5. The present project is over the catchment of Beas River. As the River Basin study of Beas river has already been carried out, the comment on following points may be provided to this office:-
 - (a) Total carrying capacity of the 'Beas river basin in terms of power generation. How much is utilized so far and how much is yet to utilised by the State.
 - (b) Since the project is below 25 MW and does not cover under the provisions of EIA, 2006. Therefore, how the mitigative measures would be addressed by the State Government for these projects.
6. The State Government may provide FRA Certificate along with all annexures.
7. The State Government may provide Techno Economic Clearance and Implementation Agreement to this office.
8. The State Government may provide detailed Layout/Site Plan of the project.
