Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of 1.7 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

- 2. After careful examination of the above-mentioned proposal of the Govt of J&K the following information/clarification are still required to be submitted:
 - (i) Table at 4(ii) is required to be corrected as per enumeration list. The girth class should be 0-30, 30-60, 60-90...and so on in centimetres. Further, trees in the girth class 30-60 should not be counted as saplings.
- 3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
