Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of **12.052** ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. The proposal was placed before the REC on 18.06.2021 and 15.09.2021 which after careful examination of the above-mentioned proposal of the Govt of J&K sought following information / clarification:

- (i) B-2.4 of part-I of the proposal shows area proposed for diversion as 12.0502 ha instead of the proposed extent of 12.052 ha. Area statement to be corrected.
- (ii) Govt. of Jammu & Kashmir to constitute a joint team to visit such areas of non-forest on ground and carry a detailed inquiry about the status of non-forest land appearing like forest area to rule out any misgivings. Joint inspection report to be furnished before the next REC meeting.
- (iii) Fresh enumeration list of trees to be felled in this proposal to be submitted correctly in view of the findings of the Joint Committee suggested by the REC.
- (iv) Revised KML with detailed demarcation of forest and non-forest land to be submitted. Along with the clarification/justification of no increase in forest area for despite a tangible increase in the length of the road passing through forest area.

- (v) Details of acquisition of proposed dumping sites in non-forest land/private land to be submitted.
