महोदय,


उपर्युक्त प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित त्रुटियाँ पाई गयी। राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:-

- 1- The details of the FCA approval or the documents supporting the fact that the existing road was constructed prior to 1980 have not been provided. State Government is requested to provide the information in this regard.
- 2- The habitation is already connected with a road. Lot of landslides are to be seen along the other roads constructed in the same locality. Construction of yet another road without any explicit purpose may lead to further degradation of the fragile landscape. Hence, State Government is requested to provide the justification for the requirement of another road in the view of above.
- 3- As per the land schedule, additional RoW of 4m is proposed. A layout plan for the proposed road shall be submitted.
- 4- Details of non-forest land involved in the proposal shall be provided in Part I at all designated places.
- 5- Details of muck dumping sites shall be provided at para B 2.4 in Part I.
- 6- On perusal of KML file, the proposal seems to be for construction of a new road to connect the village 'Sasaman' rather than for widening of existing road. The State Government is requested to submit the clarification in this regard.
- 7- The alignment of the proposed road does not match with that of the digital map. State Govt. is requested to clarify this discrepancy and upload correct KML file/ digital map.
- 8- Digital map and SOI toposheet are not legible. Digital map and SOI toposheet of higher resolution shall be provided.

- 9- Village Level Committee (VLC) meeting proceedings of village *Balawali* shall be uploaded.
- 10- Density of the proposed forest area is mentioned as zero despite having 984 trees. State Govt. is requested to provide the correct information in this regard.
- 11- Eco class and density are not mentioned in NPV calculation sheet and it is submitted that this information is not available in working plan. Necessary information in this regard shall be provided.
- 12- At para 5 in Part II, it is mentioned that 'no prescription in working plan', for the Protected Forest in Laksar and Roorkee Range'. This information required to be reviewed.
- 13- Muck disposal plan, bar chart and geologist report are not found uploaded in addl. Document in part I, which is required to be uploaded.
- 14- Work not start certificate shall be provided in the part II.
- 15- Tree enumeration list of only one range i.e. Lakshar is uploaded in part I. It is requested to upload the tree enumeration list for both the ranges in the part II. Further, it is also requested to submit the no. of trees actually required to be felled.
- 16- Details of the muck disposal sites shall be marked on the KML file.

उपरोक्त त्रुटियों की पूर्तता के उपरांत ही प्रस्ताव पर अग्रिम कार्यवाही की जा सकेगी एवं यदि चाही गई सूचना पत्र जारी होने की तिथि के 60 दिनों के भीतर (अधिकतम 90 दिन) इस कार्यालय में प्राप्त नहीं हुई तो प्रस्ताव को निरस्त किया जा सकता है।
