Sir,

In inviting a reference to the subject and letter cited above, I am to inform that this instant proposal for diversion of 5.5 ha of forest land for quarrying of stone/road metal at Longa Koirang, Kangpokpi District, Manipur in favour of The M/S Shyam Chand & Sons was sent to Ministry of Env., Forest & Climate Change, New Delhi by IRO, Shillong for consideration of approval by the competent authority. This proposal is received back in IRO, Shillong from Ministry New Delhi, wherein Ministry, New Delhi has sought additional information on the following:

- 1) Purpose wise breakup of the forest land.
- 2) Non-Availability of non-forest land certificate for CA needs to be issued by the Chief Secretary but the same is issued by the District Collector.
- 3) In the proposed area for diversion State Government has reported scheduled-I and II species like Monitor lizard, Leopard, Hoolock gibbon, pheasants, Hornbill, Himalayan Black bear, etc. Comments of Chief Wildlife Warden about mitigation measures, if any, for wildlife may be submitted.
