

I am directed to refer to State Government's letter No. FEE 41 FLL 2020 (e) dated 18/09/2021 on the above subject mentioned above and to inform that KML file of the CA area furnished by the State Forest Department does not includes the KML files of CA raised in nonforest area to an extent of 55.0 ha in Shivamogga District. Therefore, it is requested to furnish the same at the earliest.

Further, the State Government was requested to furnish complete compliance report in respect of the forest area diverted earlier to an extent of 2259 ha for Seabird project. However, the Compliance report submitted by the user agency in this regard is provided by the State Government. Therefore, it is requested to kindly provide the conditions wise compliance report duly verified by the State Forest Department.
