- 7. Layout plan of project site as per checklist has not furnished.
- 8. Map showing Safety Zone area of the forest land to be diverted has not furnished.
- 9. Total Species wise tree enumeration list of the forest land to be diverted has not furnished.
- 10. Total Species wise tree enumeration list of the Non- forest land to be diverted has not furnished.
