On verification of the Forest Diversion Proposal the following discrepancies have been observed as furnished below.

1. Authenticated DGPS Survey Map location of CA land with KML file should be furnished.
2. Undertaking for No National Park/ Wild Life Sanctuary/ Biosphere Reserves / Tiger Reserve or NWC in the project areas.
3. Undertaking as regards Wildlife Scheme in case of applicable.
4. Undertaking as regards Forest Right Act, (FRA) Certificate.
5. Undertaking as regards Minimum use of Forest land.
6. The land scheduled of 18.389 ha of forest land proposed to be diverted duly signed by the User Agency and authenticated by the concerned Tehsildar and Range Officer in the following proforma has to be furnished.

7. Check list & DP is not properly paginated in the diversion proposal.
8. Status of land (Both Hal & Sabik) Kisam as on 25.10.1980 from the competent authority.
9. You have submitted the tree enumeration list in the diversion proposal (at page No. 44 to 64) over forest land but the girth wise abstract with Botanical name has not been mentioned & authenticated by the concerned Range

Officer in the tree enumerated list & its is wanting. However you are requested to conduct joint verification over Forest & Non- Forest land along with Revenue and Forest Official to ascertain the forest growth & the trees to be taken in the project area.

10. Alternate alignment showing in Cadastral Map & Topo Sheet should be furnished.
11. All Maps should be authenticated by Concerned Tahasildar & Range Officer.
12. Brief note of the project should be furnished.
13. Justification of the project should be furnished.
14. You have submitted land use plan but Heading of Map & Signature of Revenue & Forest Official is not furnished.
15. You have submitted the Topo Sheet No. F44L12 in 1:50,000 but signature of all concerned is wanting.
16. Layout plan (alignment) has not been furnished.
17. Progress on Forest Right Certificate for issue of FRA certificate by the collector & D.M, Sundargarh.

However, the forest diversion proposal in Six Sets is returned here with for re-submission after due compliance through EDS at an early date for submission of forest diversion proposal to the higher quarter.

It is most urgent.
