4. FRA certificate is not found properly uploaded and also not clear.

Action Required:-State Govt. may upload clear and duly filled FRA online at web portal.

5. The number of trees affected is mentioned as 41 in hard copy, where as it is mentioned as 89 in the enumeration list uploaded in part-II.

Action Required:-State Govt. may correct the discrepancy of number of trees in online portal at para-4 (ii) Part-II and submit in the hard copy.

6. At para 15 against S.No. 5.5 and 5.5 (a) in Part II no comment are made by DFO.

Action Required:-DFO may mention his comments at para 15 against S.No. 5.5 and 5.5 (a) in Part II.

7. Total trees affected are mentioned as 89 over 1.163 ha and density is mentioned as 0.1 which does not seen to be correct.

<u>Action Required:</u> State Govt. may review and clarify the same and may revise the density & NPV, if required.
