In the reference 3rd cited, Principal Chief Conservator of Forest,Hyderabad has informed that DGPS/GNSS survey data for the forest land submitted by the undersigned vide reference 2nd cited, has been verified by the Geomatics cell to the extent area of 4.4993 Ha for a width of 10.00 and further in the letter 4th the width of the road is reduced to 7.50 m and the area is reduced to 3.3745 Ha .In view of this the PCCF,Hyderabad has informed to prepare proposals incompleted shape in F(C) Act 1980, format for RF area and submit hard copies to the nodal officer in (8) sets for each division and 18 sets for the area falling in protected area & their eco-sensitive zones)require environment clearance)& tiger corridors, wildlife corridors.
