- 1. The C.A. Suitability Certificate issued by the Deputy Conservator of Forests, Chamarajanagara Division vide letter dated:24-03-2021 is not in complete form i.e. the CA suitability, Form-B Table-1 (Non-forest CA land Column No.5 (Plants/Ha proposed to be planted) has been left blank and Table-2 (Degraded forest land where the balance number of plants are proposed to be planted in consonance with the working Plan Prescription) has also not been mentioned. i.e. details regarding plants to be planted in the degraded forest land as the proposed CA land cannot support 1000 plants/Ha.
- And details such as Kml file, Topo Map, Geo-referenced Map with GPS reading
 of all corners also needs to be provided with regard to the degraded forest land
 by the concerned Deputy Conservator of Forests.
- The CA Scheme in Part-II 13 (iv) has not been uploaded with regard to the CA
 plantation to be raised in the identified in the identified forest and degraded
 forest land.
