Sir,

I am directed to refer to State Government's letter No. FEE 95 FLL 2021 (e) dated 09/12/2022 on the above subject. In this regard, it is informed that DCF in his site inspection report has stated that the Forest (Conservation) Act, 1980 has not been violated in the instant case. However, as per the satellite imagery, the proposed forest land has already been utilized for non forestry activities without prior approval under Forest (Conservation) Act, 1980 and therefore, the proposal is required to be processed as per the guidelines issued vide letter No.FC-11/113/2022-FC dated 08/09/2022.

It is, therefore, requested that a detailed report on violation including the names of the erring officials and their present place of posting may kindly be furnished to this office for taking further action on violation of Forest (Conservation) Act, 1980.
