
Sir,

I am directed to refer to State Government's letter No.C3/103/2019-FWLD dated 10/10/2019 on the above subject and to inform that the proposal submitted by State Government is incomplete on the following ground:-

- (i) KML file of the entire area proposed for diversion is not uploaded in the on-line proposal. KML file is uploaded for only two segments, i.e. for 0.006 ha. & 0.08 ha. For these two segments also, same map is given.
- (ii) Proposal does not contain any Comprehensive Scheme for Compensatory Afforestation as the area involved for diversion is more than 1 ha.


It is, therefore, requested that the requisite information on the above points may kindly be furnished to this office at the earliest for further consideration of the proposal.


